Grievance

PJTA filed a grievance because members were receiving their scores on their observation after the post-observation. The district agreed that the scores will be given to the member either before or during the postobservation.

After School Child Care

The district has notified some of our members in the elementary schools only that elementary teachers cannot have their children in their classroom after the student school day. PJTA believes that the district is singling out our elementary members.

PJTA is in the process of filing a notice of claim. PJTA alleges the district has violated Section 209.a.1 (d) of the Taylor Law when it unilaterally notified our members to cease and desist of having their children in their classrooms from the end of the student school day until the end of the member's workday. The district knew about the long standing past practice and the practice was consistent between the two elementary schools.

VOTE COPE

VOTE-COPE is an acronym representing the Voice Of Teachers in Education, the Committee On Political Education. VOTE-COPE is also referred to as a PAC (Political Action Committee), the non-partisan political action arm of New York State United Teachers. Funded entirely by voluntary contributions from members, VOTE-COPE is used to help union-backed candidates and campaign committees that support education and labor. VOTE-COPE helps strengthen political action programs on all levels - national, state, and local. To help on the local level, VOTE-COPE provides rebates to participating unions for political action. VOTE-COPE funds, by law, are kept separate from those of NYSUT. Decisions on the use of VOTE-COPE contributions are made by a statewide committee. Voluntary VOTE-COPE contributions can be made through payroll deduction during the current campaign, or by writing a check in the spring. Contributions or gifts to VOTE-COPE are no-tax deductible.

APPR

Just a few reminders when going through the APPR process:

Your first observation will be announced and will be the length of an entire period, or lesson.

You are <u>not</u> required to fill out any pre-observation/post observation forms.

Domain 1 should be filled out before you have your first announced observation.

Your second observation will take place during the second half of the year, and it will only be for 10-15 minutes.

The K-2 teachers will have the state assessment portion of their APPR be based on the average Regents' exams of Common Core English, Geometry, Earth Science, Physics, and United States History & Government. For anyone who does not have a state assessment attached to their class, they will use the Fourth grade science test.
